Zelto requires moisture in the soil. Apply Zelto when nematodes are active to moist soil and follow with 1/8" – 1/4" of irrigation or natural rainfall within 24 hours of application. Including an adjuvant to promote soil penetration is recommended. Repeat applications monthly to maintain nematode control.
Do not enter or allow worker entry into treated areas during the restricted-entry interval (REI) of 4 hours.				

Nematode management considerations - To obtain maximum results in a nematode management program, it is important to take soil samples prior to application to assess nematode populations and determination of an appropriate management strategy. Utilization of the services of a field person or turf management consultant who is knowledgeable in nematode management is advised.

All applicable directions, restrictions and precautions on the EPA-registered label are to be followed.
